Novell End User License Agreement

PLEASE READ THIS AGREEMENT CAREFULLY. BY INSTALLING, DOWNLOADING OR OTHERWISE USING THE SOFTWARE, YOU AGREE TO THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE WITH THESE TERMS, YOU ARE NOT PERMITTED TO DOWNLOAD, INSTALL OR USE THE SOFTWARE AND YOU SHOULD NOTIFY THE PARTY FROM WHICH YOU PURCHASED THE SOFTWARE TO OBTAIN A REFUND. THE SOFTWARE MAY NOT BE SOLD, TRANSFERRED, OR FURTHER DISTRIBUTED EXCEPT AS AUTHORIZED BY LICENSOR.

This End User License Agreement ("Agreement") is a legal agreement between You (an entity or a person) and Novell, Inc. ("Licensor"). The software product identified in the title of this Agreement for which You have acquired licenses, any media and accompanying documentation (collectively the "Software") is protected by the copyright laws and treaties of the United States ("U.S.") and other countries and is subject to the terms of this Agreement. If the laws of Your country of origin require contracts to be in the local language to be enforceable, such local language version may be obtained from Licensor upon written request and shall be deemed to govern Your purchase of licenses to the Software. Any update, mobile application, client, module or adapter or support release to the Software that You may download or receive that is not accompanied by a license agreement is Software and governed by this Agreement. If the Software is an update or support release, then You must have validly licensed the version and quantity of the Software being updated or supported in order to install or use the update or support release.

CONVERSION OF USER LICENSES TO MAILBOX LICENSES

GroupWise 2014 is licensed and sold per mailbox. If You have licensed versions of GroupWise prior to GroupWise 2014 on a user basis, then upon first installation or use of the GroupWise 2014 Software Your user licenses automatically convert at a one:one ratio to mailbox licenses. No further action is required on Your part to convert Your user licenses to mailbox licenses. If You do not want to convert Your user licenses to mailbox licenses, You may not upgrade to or deploy GroupWise 2014 and You must remain on a prior version of GroupWise. If You wish to remain on a prior version of GroupWise mailbox licenses You purchase or renew entitles You to deploy the prior version on a user basis subject to the end user license agreement accompanying the prior version, as an authorized alternative to deploying GroupWise 2014. If You have received GroupWise 2014 as a part of the Novell Open Workgroup Suite ("NOWS"), then Your mailbox licenses remain as user or device licenses as applicable and as defined in the end user license agreement for NOWS.

LICENSED USE

GroupWise 2014

The following licenses apply to Your use of the Software depending on which product licenses You have purchased. Certain benefits are available only if You are current on maintenance for Your licenses. Except for Test Mailboxes and Resource Mailboxes, each GroupWise mailbox created using the Software requires the purchase of a Full Client License, Limited Client License, or Inactive License based on the use as specified below. You may transfer licenses between mailboxes as Your usage changes. For example, You can buy an Inactive License for a Full Client License mailbox that is no longer used for purposes other than archive and transfer that Full Client License to another mailbox.

<u>GroupWise Mailbox Full Client License</u>. A Full Client License is required for each mailbox that has been accessed by one or more of the following: the GroupWise client for Windows or Mac (grpwise.exe), GroupWise Notify (notify.exe), GroupWise Address Book (addrbook.exe), or a third-party plug-in to the GroupWise client API.

<u>GroupWise Mailbox Limited Client License</u>. A Limited Client License may be used only for a mailbox that has been accessed solely by GroupWise WebAccess (including mobile devices), GroupWise client for Windows via the Proxy feature, GroupWise client for Windows via the busy search feature, a mobile device that is synchronizing GroupWise through GroupWise Mobility Service, a POP client, an IMAP client, a SOAP client or a third-party plug-in to the GroupWise SOAP protocol.

<u>GroupWise Mailbox Inactive License</u>. An Inactive License may be used only for a mailbox that is designated as an inactive mailbox by the administrator by explicitly setting the mailbox to an Inactive License and at least sixty (60) days have passed since the inactive mailbox designation has occurred. An Inactive License permits You to use any GroupWise client method to access the inactive mailbox. However, an inactive mailbox cannot receive messages and has other limitations on functionality consistent with the inactive status.

<u>GroupWise Test Mailbox</u>. You are not required to purchase a license for a GroupWise Test Mailbox, which is defined as follows: 1) no more than two (2) mailboxes per post office that exist in Your internal, production environment but are used solely for testing purposes; or 2) no more than twenty-five (25) mailboxes that exists in Your internal, non-production environment and that are used solely for testing or demonstration purposes.

<u>GroupWise Resource Mailbox</u>. You are not required to purchase a license for a GroupWise Resource Mailbox, which is a mailbox created and designated as a resource mailbox as described in the GroupWise user documentation. GroupWise Resource Mailboxes include mailboxes used for a place, item or role (such as a computer, company vehicle, or conference room) that users can schedule or busy search. If You have purchased licenses for the Novell iPrint product, a GroupWise Resource Mailbox can be used to facilitate mobile printing.

NetlQ® eDirectory™ License. The quantity of user licenses for the NetlQ eDirectory software included with Your lawfully acquired licenses of the Novell GroupWise 2014 Software is equal to the greater of (1) the quantity of mailbox licenses You have lawfully acquired for the Novell GroupWise 2014 Software, or (2) 250,000 users per company/entity. The foregoing eDirectory licenses are not upgradeable and are otherwise subject to the license agreement accompanying the eDirectory software and the definition of "user" specified therein.

SLES® License. Notwithstanding the license rights in the license agreement accompanying the copy of SUSE® Linux Enterprise Server ("SLES") You received with the Software, You agree to use SLES solely for the purpose of running GroupWise Software received from Novell and not as a general purpose operating system. In addition, SLES may be installed only on servers on which the Software is also installed. As a benefit of Your maintenance or subscription coverage for the Software, You are entitled to a free Basic Subscription for SLES offered through SUSE. Terms and conditions for the Basic Subscription are set forth by SUSE and may be found at https://www.suse.com/support. The Basic Subscription applies only to use of SLES as authorized herein and may not be used for any other purpose. Your Basic Subscription terminates on the earlier of (1) termination or expiration of maintenance coverage for Your Software licenses, or (2) purchase of maintenance coverage for less than the total number of Your Software licenses. If You have licensed the Software under an academic or school licensing program, then the reference to maintenance coverage in this paragraph refers to Your subscription coverage.

GroupWise Mobility Service

Use of the GroupWise Mobility Service Software is a benefit of Your maintenance or subscription coverage. You are granted a limited license to reproduce and internally use the GroupWise Mobility Service Software to sync data to mobile devices for GroupWise users licensed either through the Novell GroupWise or Novell Open Workgroup Suite products (each an "Associated Product"). The foregoing license grant applies solely during Your maintenance or subscription term for the Associated Product. Your limited GroupWise Mobility Service license will receive maintenance benefits equivalent to those applicable to Your Associated Product maintenance or subscription period. Your license to use the GroupWise Mobility Service Software terminates and You must entirely delete the GroupWise Mobility Service Software from Your system upon the earlier of (1) termination or expiration of maintenance or subscription coverage of Your Associated Product licenses, or (2) purchase of maintenance coverage for less than the total number of Your Associated Product licenses.

Novell Messenger

If You have purchased standalone licenses for Novell Messenger, then You must have a license for each User (as defined in the end user license agreement accompanying the Novell Messenger Software).

Otherwise, use of Novell Messenger is a benefit of Your maintenance or subscription coverage. If You have purchased mailbox licenses for GroupWise 2014 on a subscription basis or are current on Your maintenance coverage for Your GroupWise 2014 licenses, then You are entitled to use Novell Messenger in a quantity of User licenses equal to the aggregate number of Your GroupWise 2014 mailbox Full Client Licenses and Limited Client Licenses. If You have purchased licenses for Novell Vibe™ on a subscription basis or are current on Your maintenance coverage for Your Novell Vibe licenses, then You are entitled to use Novell Messenger in a quantity of User licenses equal to that of Your Novell Vibe licenses. Your license to use the Novell Messenger Software terminates and You must entirely delete the Novell Messenger Software from Your system upon the earlier of (1) termination or expiration of maintenance or subscription coverage, or (2) purchase of maintenance coverage for less than the total number of Your GroupWise 2014 or Vibe licenses.

GroupWise Coexistence Solution for Exchange

Coexistence is an optional technology provided with GroupWise that You must license separately on an annual subscription basis to enable utilization with supported versions of Exchange. Current maintenance coverage or a subscription is a prerequisite for licensing and continued use of Coexistence. You must acquire subscriptions for the total number of GroupWise mailboxes or the total number of Exchange users synchronized with Coexistence, whichever quantity is smaller. Use of Coexistence subscriptions is conditioned on being current on maintenance coverage for all of Your GroupWise mailbox licenses. Your Coexistence subscription and right to use the Coexistence technology terminates and You must uninstall from Your systems and discontinue use of Coexistence upon the earlier of (1) termination or expiration of maintenance coverage on Your GroupWise licenses, or (2) purchase of maintenance coverage for less than the total number of Your GroupWise licenses. If You have licensed GroupWise under an academic or school licensing program, then the reference to maintenance coverage in this paragraph refers to Your subscription coverage.

Evaluation Software. If the Software is an evaluation version or is provided to You for evaluation purposes, then, unless otherwise approved in writing by an authorized representative of Licensor, Your license to use the Software is limited solely for internal evaluation purposes in non-production use and in accordance with the terms of the evaluation offering under which You received the Software and expires sixty (60) days from installation (or such other period as may be indicated within the Software). Upon expiration of the evaluation period, You must discontinue use of the Software, return to an original state any actions performed by the Software, and delete the Software entirely from Your system and You may not download the Software again unless approved in writing by an

authorized representative of Licensor. The Software may contain an automatic disabling mechanism that prevents its use after a certain period of time.

RESTRICTIONS

<u>License Restrictions</u>. Licensor reserves all rights not expressly granted to You. The Software is licensed for Your internal use only. Except as this Agreement expressly allows, You may not (1) copy (except for back-up purposes), modify, alter, create derivative works, reverse engineer, decompile, or disassemble the Software except and only to the extent expressly permitted by applicable law; (2) transfer, assign, pledge, rent, timeshare, host or lease the Software, or sublicense any of Your license grants or rights under this Agreement; in whole or in part, without prior written permission of Licensor; (3) remove any patent, trademark, copyright, trade secret or other proprietary notices or labels on the Software or its documentation; or (4) disclose the results of any performance, functional or other evaluation or benchmarking of the Software to any third party without the prior written permission of Licensor.

<u>Hosting Restrictions</u>. In the event that You desire to have a third party manage, host (either remotely or virtually) or use the Software on Your behalf, You shall (1) first enter into a valid and binding agreement with such third party that contains terms and conditions to protect Licensor's rights in the Software that are no less prohibitive and/or restrictive than those contained in this Agreement, including, without limitation, the Verification section below; (2) prohibit use by such third party except for the sole benefit of You; and (3) be solely responsible to Licensor for any and all breaches of the above terms and conditions by such third party.

<u>Suite Licenses</u>. If Your license to use the Software is for a suite of products, then for each license only one user may use the products in the suite. The suite license does not allow use of individual products in the suite by multiple users if licensed on a user basis or multiple devices if licensed on a device or server basis.

<u>Upgrade Software</u>. This section applies to You if You have purchased the Software based upon upgrade pricing or otherwise received an upgrade or update to the Software. "Original Product" means the product from which You are upgrading. You are authorized to use the Software only if You are the authorized user of the Original Product and You may use the Software to replace Your licensed unit count of the Original Product on a one-for-one basis, not exceeding the authorized licensed unit count for the Original Software. This Agreement shall replace and govern any license agreement for the surviving units of Original Product. <u>Maintenance and Support</u>. Licensor has no obligation to provide support unless You purchase an offering that expressly includes support services. If You make such a purchase and no separate agreement specifically applies to the support services, then the terms of this Agreement will govern the provision of such support services ("Services"). OWNERSHIP

No title to or ownership of the Software is transferred to You. Licensor and/or its third party licensors retain all right, title and interest in and to all intellectual property rights in the Software and Services, including any adaptations or copies thereof. The Software is not sold to You, You acquire only a conditional license to use the Software. Title, ownership rights and intellectual property rights in and to the content accessed through the Software are the property of the applicable content owner and may be protected by applicable copyright or other law. This Agreement gives You no rights to such content.

LIMITED WARRANTY

For ninety (90) days from Your date of purchase, Licensor warrants that the Software will substantially conform to its accompanying documentation. If You report the nonconformity to Licensor within ninety (90) days from the date of purchase, Licensor will at its sole discretion either resolve the nonconformity or refund the license fees You paid for the Software. Any unauthorized use or modification to the Software voids this warranty. THE FOREGOING WARRANTY IS YOUR SOLE AND EXCLUSIVE REMEDY AND IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED. The foregoing warranty does not apply to Software provided free of charge. SUCH SOFTWARE IS PROVIDED "AS IS" WITHOUT ANY WARRANTIES OF ANY KIND.

<u>Services</u>. Licensor warrants that any Services purchased will be supplied in a professional manner in accordance with generally accepted industry standards. This warranty will be effective for thirty (30) days following delivery of the Services. Upon any breach of this warranty, Licensor's only obligation is to either correct the Services so that they comply with this warranty or at its option refund the amount You paid to Licensor for the portion of the Services that fail to comply with this warranty. You agree to take appropriate measures to isolate and back up Your systems.

If an audit reveals that You have or at any time have had unlicensed installation, use of, or access to the Software, You will, within 30 days, purchase sufficient licenses to cover any shortfall without benefit of any otherwise applicable discount and subject to license fees reflecting the duration of the shortfall. Law. All matters arising out of or relating to the Agreement will be governed by the substantive laws of the United States and the State of Utah without regard to its choice of law provisions. Any suit, action or proceeding arising out of or relating to the Agreement may only be brought before a federal or state court of appropriate jurisdiction in Utah. If a party initiates Agreement-related legal proceedings, the prevailing party will be entitled to recover reasonable attorneys' fees. If, however, Your country of principal residence is a member state of the European Union or the European Free Trade Association, (1) the courts of Ireland shall have exclusive jurisdiction over any action of law relating to this Agreement; and (2) where the laws of such country of principal residence are required to be applied to any such action of law the laws of that country shall apply. The application of the United Nations Convention of Contracts for the International Sale of Goods is expressly excluded.

Entire Agreement. This Agreement, together with any other purchase documents or other agreement between You and Licensor,

sets forth the entire understanding and agreement between You and Licensor and may be amended or modified only by a written agreement agreed to by You and an authorized representative of Licensor. If any provision in this Agreement is invalid or unenforceable, that provision will be construed, limited, modified or, if necessary, severed, to the extent necessary, to eliminate its invalidity or unenforceability, and the other provisions of this Agreement will remain unaffected.

Export Compliance. You acknowledge that Licensor's products and/or technology are subject to the U.S. Export Administration Regulations (the "EAR") and You agree to comply with the EAR.
